RESOLUTION NO. 223-2014

**AWARDING A CONTRACT FOR
TREE MAINTENANCE SERVICES FOR 2015**

WHEREAS, bids were received by the Chief Finance Officer for Tree Maintenance Services on December 3, 2014; and

WHEREAS, three (3) bids were received as follows:

WHEREAS, the bid specifications provide that the Township may award a contract by a section or parts to the lowest responsible bidder for that section or part; and

WHEREAS, the bid documents have been reviewed by the Acting Director of Public Works who recommended that:

1. Hyperion Tree Service be awarded a contract for Tree Removal Services (Section 1, Priority 1 and 2) in the amount of \$30,000; and
2. Greenscape Landscape Contractor, Inc. be awarded a contract for Tree Trimming Services (Section 2) at a rate of \$179/hour, not to exceed 284 hours, or \$50,836; and

WHEREAS, the Deputy Manager/Chief Financial Officer has filed the required Certification of Funds with the Township Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. A contract is hereby awarded to Hyperion Tree Service in the amount of \$30,000 for Tree Removal Services (Priority 1 and 2).

2. A contract is hereby awarded to Greenscape Landscape Contractor, Inc. in an amount not to exceed \$50,836 for Tree Trimming Services.
3. The Mayor and Township Clerk are hereby authorized to sign said contract and other documents necessary to implement this resolution.
4. Said contracts shall run from January 1, 2015 until December 31, 2015.
