

TOWNSHIP OF MOORESTOWN

RESOLUTION NO. 54-2015

AUTHORIZING THE EXECUTION OF AN INTERMUNICIPAL SERVICES AGREEMENT WITH THE COUNTY OF BURLINGTON FOR THE DISPOSAL OF DEWATERED SLUDGE GENERATED AT THE TOWNSHIP OF MOORESTOWN WASTEWATER TREATMENT PLANT

WHEREAS, the County of Burlington has been designated as a Solid Waste Management District (the "District") and, as such, is responsible for the development, adoption and implementation of the Burlington County Solid Waste Management Plan (the "Plan") to provide for the long-term solid waste (including sludge) processing and disposal needs of the District; and

WHEREAS, pursuant to the Plan, all wastewater treatment plants located within the County are required to dewater sludge and deliver such sludge to the Facility for processing; and

WHEREAS, the County proposes to provide sludge processing and co-composting services at its Facility to all County-located wastewater treatment plants on a long-term, cost effective basis; and

WHEREAS, utilization of the Facility by all such wastewater treatment plants will ensure the provision of cost effective sludge processing and co-composting services by the County and will conserve other components of the County's Solid Waste System; and

WHEREAS, pursuant to the Local Public Contracts Law, NJSA 40A:11-1 et seq, the Township of Moorestown may enter into an Agreement with the County without public advertising for bids and bidding therefor; and

WHEREAS, the Township of Moorestown may enter into an Agreement with the County for the provision of such services by the County and for any term agreed upon by the parties; and

WHEREAS, the Township of Moorestown desires to take advantage of the County's proposal to process and co-compost, or dispose, of all dewatered sludge generated at the Township of Moorestown Municipal Wastewater Treatment Plant on such long-term, cost effective basis; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Moorestown as follows:

Section 1. The Mayor of the Township of Moorestown is hereby authorized and directed to execute an Intermunicipal Sludge Management Agreement with the County of Burlington, in substantially the form attached hereto, which Agreement shall be deemed a part hereof as if fully set forth herein, with such changes thereto as are approved by counsel to the Township of Moorestown; and

Section 2. The effective date of the Agreement shall be January 1, 2015 through December 31, 2019.

Section 3. The Township Clerk is hereby authorized and directed to attest to the signature of the Mayor and to affix on the execution counterparts of the Agreement, the official seal of the Township of Moorestown.

Section 4. This Resolution shall take effect immediately.
