**RESOLUTION NO. 61-2015**

**APPROVING PERSON-TO-PERSON/PLACE-TO-PLACE TRANSFER OF  
PLENARY RETAIL CONSUMPTION LICENSE NO. 0322-33-004-001  
(MOORESTOWN BEVERAGE II, LLC TO  
HARVEST MOORESTOWN, LLC)**

**WHEREAS**, an application has been filed for a Person-to-Person/Place-to-Place Transfer of Plenary Retail Consumption License Number 0322-33-004-001 issued to Moorestown Beverage II, LLC for an inactive (pocket) license with a mailing address of 200 South Broad Street, Philadelphia, PA 19102; and

**WHEREAS**, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

*“This license, subject to all its terms and conditions, is hereby transferred, effective February 9, 2015, to Harvest Moorestown for premises located at 400 Route 38, Moorestown Mall, Unit 1380, Moorestown, New Jersey 08057.”*

**BE IT FURTHER RESOLVED** that the Township Council of the Township of Moorestown does hereby approve, effective February 9, 2015 the Place-to-Place Transfer of the aforesaid Plenary Retail Consumption licensed premises, from its former business address at 200 South Broad Street, Philadelphia, PA 19102-3803 to its new location at 400 Route 38, Moorestown Mall, Unit 1380, Moorestown, New Jersey 08057 and does hereby direct the Township Clerk to endorse the license certificate as follows:

*“This license, subject to all of its terms and conditions, is hereby transferred, effective February 9, 2015, from Moorestown Beverage II, LLC, 200 South Broad Street, Philadelphia, PA 19102-3803 to premises located at 400 Route 38, Moorestown Mall, Unit 1380, Moorestown, New Jersey 08057.”*
