**RESOLUTION NO. 70-2015**

**ACCEPTING THE WITHDRAWAL OF GREENSCAPE LANDSCAPE CONTRACTORS,  
INC. AND AWARDING A CONTRACT TO INTEGRATED TURF MANAGEMENT  
IN THE AMOUNT OF \$23,265 FOR  
2015 CORING AND SEEDING OF ATHLETIC FIELDS**

**WHEREAS**, bids were received by the Chief Financial Officer on February 18, 2015 for the Coring and Seeding of Athletic Fields; and

**WHEREAS**, five (5) bids were received as follows:

**WHEREAS**, Greenscape Landscape Contractor Inc., via correspondence dated February 19, 2015, officially notified the Township that it made a “mistake” as defined at N.J.S.A. 40A:11-2(42), and is, therefore, withdrawing its bid pursuant to N.J.S.A. 40A:11-23.3; and

**WHEREAS**, Greenscape Landscape Contractor Inc.’s bid has been found to be non-responsive as it does not conform in all material respects to the terms and conditions of the specifications.

**WHEREAS**, the Township Manager has reviewed the matter and, due to a significant material defect, finds it in the best interest of the Township for Council to accept the withdrawal of Greenscape Landscape Contractor Inc.’s bid; and

**WHEREAS**, the bid documents have been reviewed by Theresa Miller, Recreation Director, who has recommended that the lowest “responsible” bidder, Integrated Turf Management, be awarded the contract; and

**WHEREAS**, the Chief Finance Officer has filed the required Certification of Funds with the Township Clerk.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that:

1. The withdrawal of Greenscape Landscape Contractors, Inc. be accepted.
2. The contract for the Coring and Seeding of Athletic Fields for 2015 be awarded to the lowest “responsible” bidder, Integrated Turf Management, PO Box 5006, New Britian, Pennsylvania 18901 in the amount of \$23,265.
3. The Mayor and Township Clerk are hereby authorized to sign said contract and other documents necessary to implement this resolution.
