RESOLUTION NO. 124-2015

**APPOINTING ANNA BUSS AND CHRISTOPHER FOLGIA AS ADDITIONAL MEMBERS
(SOPHOMORE STUDENTS) TO THE RECREATION ADVISORY COMMITTEE**

WHEREAS, Ordinance 14-2014, adopted on October 6, 2014, created two additional, two-year-term seats (one male and one female sophomore student) on the Recreation Advisory Committee; and

WHEREAS, Ordinance 14-2014 states, "Upon adoption of this section, two students, one male and one female, entering into their sophomore year shall be appointed to a two-year term;" and

WHEREAS, appointments, as anticipated, were not made in 2014; and

WHEREAS, due to the fact that new appointments to the new seats were not made in 2014, Council wishes to make new appointments in 2015, rather than fulfilling unexpired terms; and

WHEREAS, Moorestown High School students, Anna Buss and Christopher Folgia, students entering into their sophomore year in September 2015, have submitted a Request to Serve on the Recreation Advisory Committee; and

WHEREAS, the Township Council wishes to appoint Ms. Buss and Mr. Folgia as additional members (male and female sophomores) on the Recreation Advisory Committee, effective July 1, 2015; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that, contrary to the ordinance provisions, due to the fact that new appointments were not made in 2014, appointments to the sophomore seats shall be considered new with a term expiring in two years, i.e., July 1, 2015 through June 30, 2017.

BE IT FURTHER RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that the following students be appointed, effective July 1, 2015, to the Recreation Advisory Committee with terms expiring as follows:

BE IT FURTHER RESOLVED that the vacant additional member (female junior) seat that is to expire on June 30, 2015 remain vacant and that two juniors (one male and one female) be appointed for the term July 1, 2015 through June 30, 2016 as soon as appointments can be made.
