

**TOWNSHIP OF MOORESTOWN**

**RESOLUTION NO. 139-2015**

**AWARDING A PROFESSIONAL SERVICES CONTRACT TO  
PRINCETON HYDRO, LLC IN AN AMOUNT NOT TO EXCEED \$80,000**

WHEREAS, in an effort to improve the deteriorating environmental condition of Strawbridge Lake, Township Council, in 2014, retained the services of Princeton Hydro, who reviewed and analyzed current conditions, performed various tests, prepared reports and performed a bathymetric survey; and

WHEREAS, the Township is in need of the professional services of an environmental engineering firm to perform the environmental-related work recommended by Princeton Hydro; and

WHEREAS, Township Council wishes to retain the services of Princeton Hydro to perform the improvements recommended in its proposal dated May 24, 2015 (revised June 11, 2015) in order to properly maintain and preserve Strawbridge Lake; and

WHEREAS, funds are available for this purpose; and

WHEREAS, a Determination of Value Form, certifying that the costs associated with said services will exceed \$17,500, has been filed with the Township Clerk; and

WHEREAS, an executed Business Entity Disclosure Certification, which certifies that the contractor has not made any reportable contributions to a political or candidate committee in the Township of Moorestown in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of the contract, has been received by the Township Clerk; and

WHEREAS, an executed Political Contribution Disclosure Form was filed with the Municipal Clerk at least ten (10) days prior to award of the contract; and

WHEREAS, the Township of Moorestown has met the provisions of the NJ Local Unit Pay-to-Play Law to award a contract under the Non-Fair and Open Contracts provisions of the Law.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. Princeton Hydro, LLC, 1108 Old York Road, PO Box 720, Ringoes, New Jersey 08551 is hereby awarded a contract, in an amount not to exceed \$80,000, for professional engineering services, pursuant to the provisions of N.J.S.A. 19:44a-20.5 and Chapter 10 of the Code of the Township of Moorestown.

2. A contractual agreement is hereby approved and execution of the contract is authorized.
3. A copy of the aforementioned contractual agreement shall be filed in the Office of the Township Clerk and made available for public inspection.
4. The Business Entity Disclosure Certification, Political Contribution Certification and Determination of Value Form shall be placed on file with this resolution.
5. The Township Clerk is hereby authorized to publish a "Notice of Award" of said contract in the official newspaper in accordance with the Local Public Contracts Law, within ten (10) days of its passage.
