WHEREAS, under N.J.S.A. 40A:11-23.2, a signed bidder's acknowledgement receipt of any notice or revisions or addenda to the advertisement or bid documents is a mandatory

requirement and failure to submit same must be considered a fatal, incurable defect that shall render the bid proposal unresponsive; and

WHEREAS, Garden State Earthwork failed to include a completed/signed addenda form in his bid submission hence rendering his proposal unresponsive; and

WHEREAS, the bid documents have been reviewed by Scott Taylor, Township Planner, who has recommended, by letter dated August 18, 2016, that the lowest “responsible” bidder, Command Company, Inc., be awarded the contract, which shall include the Base Bid plus Alternate 1 and 2 for a total contract price of \$353,519.00; and

WHEREAS, the Chief Financial Officer has filed the required Certification of Funds with the Municipal Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that:

1. A contract be awarded to the lowest responsible bidder, Command Co., Inc., 1318 Antwerp Avenue, Egg Harbor City, New Jersey 08215 in the amount of \$353,519.00.
2. The Mayor and Municipal Clerk are hereby authorized to sign said contract and other documents necessary to implement this resolution.
