RESOLUTION NO. 200-2016

**A RESOLUTION AUTHORIZING A PUBLIC AUCTION
OF TANGIBLE PERSONAL PROPERTY FOUND OR RECOVERED
PURSUANT TO N.J.S.A. 40A:14-157**

WHEREAS, N.J.S.A. 40A:14-157 provides that the Governing Body may authorize, by resolution, the sale of tangible personal property by way of public sale; and

WHEREAS, the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, is desirous of providing for the sale of approximately fourteen (14) unclaimed bicycles and one (1) electric edge trimmer, at public auction pursuant to statute.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that pursuant to N.J.S.A. 40A:14-157, a public auction of approximately fourteen (14) unclaimed bicycles and one (1) electric edge trimmer will be held by the Police Department on Saturday, December 3, 2016 at 9:00 a.m. prevailing time (preview of all bikes begins at 8:30 a.m.), in the rear of the Police Department, 1245 North Church Street, Moorestown, New Jersey 08057.

BE IT FURTHER RESOLVED that all said monies collected by such auction shall be deposited with the Treasurer of the Township of Moorestown, pursuant to the statute.

BE IT FURTHER RESOLVED that legal notice of this public auction will be published in the official newspaper of the Township of Moorestown at least ten (10) days prior to the sale.

BE IF FURTHER RESOLVED that said legal notice contain a statement advising where and when the public may view the unclaimed bicycles prior to the sale to determine if his/her bicycle is among the bicycles to be sold.
