

**TOWNSHIP OF MOORESTOWN**

**RESOLUTION NO. 213-2016**

**AWARDING CONTRACT WITH WATER REMEDIATION TECHNOLOGY LLC  
FOR THE RENTAL OF A TEMPORARY RADIUM REMOVAL SYSTEM FOR USE AT  
THE NORTH CHURCH STREET WATER TREATMENT PLANT**

WHEREAS, on August 8, 2016, the Township Council approved a contract with Water Remediation Technology LLC for the temporary rental of a radium removal system at the North Church Street Water Treatment Plant; and

WHEREAS, three (3) additional filtration units are necessary in order to complete the temporary treatment system installation project; and

WHEREAS, pursuant to N.J.S.A. 40A:11-5(1)(gg), the Township is authorized to enter into a contract with a vendor to acquire the additional filters without public bidding; and

WHEREAS, a Determination of Value Form, certifying that the costs associated with said services will exceed \$17,500, has been filed with the Township Clerk; and

WHEREAS, there are sufficient funds for the proposed purchase; and

WHEREAS, an executed Business Entity Disclosure Certification, which certifies that the contractor has not made any reportable contributions to a political or candidate committee in the Township of Moorestown in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of the contract, has been received by the Township Clerk; and

WHEREAS, an executed Political Contribution Disclosure Form was filed with the Municipal Clerk at least ten (10) days prior to award of the contract; and

WHEREAS, the Township of Moorestown has met the provisions of the NJ Local Unit Pay-to-Play Law to award a contract under the Non-Fair and Open Contracts provisions of the Law.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. Water Remediation Technology LLC, whose business address is 5525 West 56<sup>th</sup> Avenue, Suite 100, Arvada, Colorado 80002, is hereby awarded a contract for the rental of an interim treatment for radium removal as follows:
  - a. Provide process treatment (3 each 200gpm treatment trains), equipment and services: \$346,804.00;

- b. Decommissioning (packaging, transportation, licensed disposal and disposition paperwork: \$100,300.00; and
  - c. Rental fee after initial six (months): \$9,700.00/month
2. Upon expiration of the first six-month rental term, the Township of Moorestown shall have the option to continue renting the equipment at a cost of \$9,700.00/month until such time as a permanent treatment is installed.
  3. Entry into a contract with the selected vendor is hereby approved, and the execution of an appropriate form of contract is hereby authorized.
  4. A copy of the aforementioned contractual agreement shall be filed in the Office of the Township Clerk and made available for public inspection.
  5. The Business Entity Disclosure Certification, Political Contribution Disclosure and Determination of Value Form be placed on file with this resolution.
  6. The Township Clerk is hereby authorized to publish a “Notice of Award” of said contract in the official newspaper in accordance with the Local Public Contracts Law, within ten (10) days of its passage.
