RESOLUTION NO. 93-2017

AWARDING A CONTRACT FOR TREE REMOVAL AND TRIMMING SERVICES AT STRAWBRIDGE LAKE (ALONG ROUTE 38) TO RICH TREE SERVICE, INC. IN THE AMOUNT OF \$24,350

WHEREAS, the Township of Moorestown received a Community Stewardship Incentive Program – Hazard Mitigation Grant (Identifier No. S17-022) from the New Jersey Department of Environmental Protection, State Forest Service in the amount of \$25,000; and

WHEREAS, bids were received by the Chief Financial Officer for Tree Removal and Trimming Services at Strawbridge Lake (Along Route 38) on March 15, 2017; and

WHEREAS, two (2) bids were received as follows:

WHEREAS, the bid documents have been reviewed by Doug Nims, General Supervisor of Public Works, who recommended, via correspondence dated March 16, 2017, that Rich Tree Service, Inc. be awarded a contract for Sections 1, 2 and 3 for a total contract amount of \$24,350; and

WHEREAS, the Township Manager/Chief Financial Officer has filed the required Certification of Funds with the Township Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. A contract in the total amount of \$24,350 is hereby awarded to Rich Tree Service, Inc., 325 Bergen Street, South Plainfield, New Jersey 07060 as follows: Section 1 (23 Tree Removals) for \$16,500.00; Section 2 (14 Tree Trimming) for \$2,750.00; and Section 3 (Alt 1) (8 Tree Removals) for \$5,100.00.

2. The Mayor and Township Clerk are hereby authorized to sign said contract and other documents necessary to implement this resolution.
