RESOLUTION NO. 103-2017

**AUTHORIZING A FOURTH AND FINAL ONE-YEAR EXTENSION OF A CONTRACT
IN THE AMOUNT OF \$15,000 TO WOOLSTON COMPANY INC. FOR THE
REMOVAL, TRANSPORTATION AND DISPOSAL OF WASTEWATER SLUDGE(S)**

WHEREAS, Woolston Company Inc., with its principal place of business at PO Box 86, Bordentown, New Jersey 08505, was awarded a Contract for the Removal, Transportation and Disposal of Wastewater Sludge(s) from May 1, 2013 through April 30, 2014; and

WHEREAS, said bid specifications and contract contained provisions, under the Terms of the Contract, that said contract was renewable for four additional years; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-15(3), states, in pertinent part, that a contract for the collection and disposal of municipal solid waste, the collection and disposition of recyclable material, or the disposal of sewage sludge, may be awarded for any term not exceeding in the aggregate, five years; and

WHEREAS, said contract was extended by the Township Council for a period of one year on March 24, 2014, a second one-year extension on March 23, 2015 and a third one-year extension on March 21, 2016; and

WHEREAS, said contract will expire on April 30, 2017; and

WHEREAS, the vendor, in his offer to extend said services and product for the 2017-2018 year has proposed an additional 6% cost increase as follows: Extension Pricing-\$15,000/year @ \$11.13/ton; and

WHEREAS, the General Supervisor of Public Works, has recommended a fourth and final one-year extension of said contract from May 1, 2017 until April 30, 2018; and

WHEREAS, the Governing Body has found that the subject services are being performed in an effective and efficient manner; and

WHEREAS, the Chief Financial Officer has filed the required Certification of Funds with the Township Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. The contract between the Township of Moorestown and Woolston Company Inc. dated April 25, 2013 is hereby extended for a fourth and final one-year period, from May 1, 2017 through April 30, 2018.
2. The contract amount shall be increased in accordance with the above-referenced rates and all other terms and conditions shall remain the same.
