RESOLUTION NO. 180-2017

**APPOINTING PENNONI ASSOCIATES, INC. AS ALTERNATE ENGINEER
AND AUTHORIZING AWARD OF A CONTRACT FOR 2017**

WHEREAS, the Township of Moorestown requires the services of a Professional Alternate Engineer for various engineering projects; and

WHEREAS, a Determination of Value Form, certifying that the costs associated with said services will exceed \$17,500, has been filed with the Township Clerk; and

WHEREAS, the Chief Finance Officer has certified funds (Appropriation No. Various Budget and Capital Accounts); and

WHEREAS, an executed Business Entity Disclosure Certification, which certifies that the contractor has not made any reportable contributions to a political or candidate committee in the Township of Moorestown in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of the contract, has been received by the Township Clerk; and

WHEREAS, an executed Political Contribution Disclosure Form was filed with the Municipal Clerk at least ten (10) days prior to award of the contract; and

WHEREAS, the Township of Moorestown has met the provisions of the NJ Local Unit Pay-to-Play Law to award a contract under the Non-Fair and Open Contracts provisions of the Law.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. Pennoni Associates, Inc., whose business address is 515 Grove Street, Suite 1B, Haddon Heights, New Jersey 08035 is hereby appointed to provide Engineering Services for the year 2017 pursuant to the provisions of N.J.S.A. 19:44a-20.5 and Chapter 10 of the Code of the Township of Moorestown. Said appointment shall expire upon the Reorganization Meeting of the Township Council in 2018.
2. A contractual agreement summarizing the services to be performed by the Engineer and the fees to be charged for same, are hereby approved and execution of the contract is authorized.
3. A copy of the aforementioned contractual agreement shall be filed in the Office of the Township Clerk and made available for public inspection.
4. The Business Entity Disclosure Certification, Political Contribution Disclosure and Determination of Value Form be placed on file with this resolution.
5. The Township Clerk is hereby authorized to publish a "Notice of Award" of said contract in the official newspaper in accordance with the Local Public Contracts Law, within ten (10) days of its passage.
