**AWARDING A CONTRACT TO MIRACLE CHEMICAL COMPANY
IN AN AMOUNT NOT TO EXCEED \$156,000 FOR PURCHASE AND DELIVERY OF
LIQUID SODIUM HYPOCHLORITE FOR THE DEPARTMENT OF PUBLIC WORKS**

WHEREAS, bids were received by the Township Manager/Chief Finance Officer on October 4, 2017 for the purchase and delivery of Liquid Sodium Hypochlorite; and
