ORDINANCE NO. 13-2013

**AN ORDINANCE OF THE TOWNSHIP OF MOORESTOWN
ACCEPTING DEED OF DEDICATION FROM
ASPEN FALLS LLC FOR THE WILSON AVENUE SUBDIVISION**

WHEREAS, Aspen Falls LLC, the developer of a residential project known as the Wilson Avenue Subdivision, has offered the dedication of Block 900, Lot 1.01 to the Township of Moorestown; and

WHEREAS, the dedication consists of one (1) stormwater basin lot; and

WHEREAS, the dedication is consistent with the subdivision approval granted by the Moorestown Planning Board; and

WHEREAS, the Township Council has, upon recommendation from the Township Planning Board Engineer and via Resolution No. 168-2011 dated October 24, 2011, called the performance guarantee for the project at the request of the developer.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, as follows:

Section 1. The Township Council accepts the Deed for the property.

Section 2. The Mayor and/or other appropriate municipal officials are hereby authorized to execute any and all documents as are necessary to complete the dedication process.

Section 3. Severability. If any section, paragraph, sentence, clause, phrase, term, provision or part of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid or unenforceable for any reason, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the section, paragraph, sentence, clause, phrase, term, provision or part thereof directly involved in the controversy in which such judgment shall have been rendered.

Section 4. Repealer. Any and all other ordinances inconsistent with any terms and provision of this ordinance are hereby repealed to the extent of such inconsistency.

Section 5. Effective Date. This ordinance shall take effect upon proper publication and in accordance with law.

Section 6. Short Title. This ordinance shall be known as Ordinance No. 13-2013.
