ORDINANCE NO. 25-2013

**AN ORDINANCE AMENDING CHAPTER 168-64 ENTITLED
“PARKING PROHIBITED AT ALL TIMES”
OF THE CODE OF THE TOWNSHIP OF MOORESTOWN**

BE IT ORDAINED by the Township Council, of the Township of Moorestown, in the County of Burlington, State of New Jersey, that:

Section 1: Chapter 168-64. Schedule XIV: “Parking Prohibited at All Times” of the Code of the Township of Moorestown, is hereby amended as follows:

- a. The following language, under Schedule XIV: “Parking Prohibited at All Times, shall be inserted:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Zelley Avenue	East	From a point 50 feet north of East Second Street to a point 150 feet north of East Second Street.
Zelley Avenue	West	From a point 630 feet north of East Main Street to a point 800 feet north of East Main Street.

Section 3: Regulatory signs shall be erected and maintained to effectuate the above designated “Parking Prohibited at All Times” locations.

Section 4: In all other respects, Chapter 168 shall remain in full force and effect.

Section 5: Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies.

Section 6: Severability. In the event that any section, paragraph, clause, phrase, term, provision, or part of this ordinance shall be adjudged by a court of competent jurisdiction, to be invalid or unenforceable for any reason, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, term, provision, or part thereof directly involved in the controversy, if such judgment is rendered.

Section 7: Effective Date. This ordinance shall take effect, upon proper publication, in accordance with law.

Section 8: Short Title. This ordinance shall be known as Ordinance 25-2013.

The ordinance published herewith was introduced and passed upon first reading at a meeting of the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, held on October 28, 2013.
