

**TOWNSHIP OF MOORESTOWN**

**ORDINANCE NO. 12-2012**

**AMENDING CHAPTER 168-64, OF THE CODE OF THE TOWNSHIP OF  
MOORESTOWN ENTITLED “VEHICLES AND TRAFFIC”  
SCHEDULE XIV “PARKING PROHIBITED AT ALL TIMES”**

BE IT ORDAINED by the Township Council, of the township of Moorestown, in the County of Burlington, that:

Section 1. Chapter 168 of the code of the Township of Moorestown is hereby amended as follows:

- a. Chapter 168-64 Schedule XIV “Parking Prohibited at All Times” of the Code of the Township of Moorestown is hereby amended to delete the following language:

<b>NAME OF STREET</b>	<b>SIDE</b>	<b>LOCATION</b>
Glen Avenue	Both	From Crider Avenue to a point 1,800 feet east of New Albany Road
Glen Court	Both	From Glen Avenue to Terminus at Glen Court

- b. Chapter 168-64 Schedule XIV “Parking Prohibited at All Times” of the Code of the Township of Moorestown is hereby amended to add the following language:

<b>NAME OF STREET</b>	<b>SIDE</b>	<b>LOCATION</b>
Whittendale Drive	Both	Entire Length
Twosome Drive	Both	Entire Length
Commerce Drive	Both	Entire Length
Executive Drive	Both	Entire Length
Lancer Drive	Both	Entire Length
Glen Avenue	Both	Entire Length
Glen Court	Both	Entire Length
Foster Road	Both	Entire Length

Section 2. Regulatory signs shall be erected and maintained to effect the above designated “Parking Prohibited at All Times” locations.

Section 3. In all other respects, Chapter 168 shall remain in full force and effect.

Section 4. Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies.

Section 5. Severability. In the event that any section, paragraph, clause, phrase, term, provision, or part of this ordinance shall be adjudged by a court of competent jurisdiction, to be invalid or unenforceable for any reason, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operations to the section, paragraph, clause, phrase, term, provision, or part thereof directly involved in the controversy, if such judgment is rendered.

Section 6. Effective Date. This ordinance shall take effect upon proper publication, in accordance with the law.

Section 7. Short Title. This ordinance shall be known as Ordinance 12-2012.
