

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 8-2011

**AN ORDINANCE AMENDING CHAPTER 168, ENTITLED
“VEHICLES AND TRAFFIC”
OF THE CODE OF THE TOWNSHIP OF MOORESTOWN**

BE IT ORDAINED by the Township Council of the Township of Moorestown, in the County of Burlington, State of New Jersey, that:

Section 1: Chapter 168-64. “Schedule XIV: Parking Prohibited at All Times” of the Code of the Township of Moorestown is hereby amended to add the following language:

| <u>NAME OF STREET</u> | <u>SIDE</u> | <u>LOCATION</u> |
|-----------------------|-------------|--|
| West Third Street | South | From North Church Street to a point 47 feet east |
| West Third Street | South | From a point 230 feet east of North Church Street to Mill Street |
| North Church Street | West | From West Third Street to a point 129 feet south |

Section 2: Regulatory signs shall be erected and maintained to effectuate the above-designated “PARKING PROHIBITED AT ALL TIMES” locations.

Section 3: Chapter 168-52. “Schedule II: “Speed Limits” of the Code of the Township of Moorestown is hereby amended by deleting the following language:

| <u>NAME OF STREET</u> | <u>SPEED LIMIT</u> | <u>ZONE</u> | <u>LOCATION</u> |
|-----------------------|--------------------|-------------|--|
| Haines Drive | 30 | (a) | From Kings Highway to Pleasant Valley Avenue |
| | 25 | (b) | From Pleasant Valley Avenue to South Church Street |

Section 4: Chapter 168-52. “Schedule II: “Speed Limits” of the Code of the Township of Moorestown is hereby amended by adding the following language:

| <u>NAME OF STREET</u> | <u>SPEED LIMIT</u> | <u>LOCATION</u> |
|-----------------------|--------------------|---|
| Centerton Road | 45 | From Westfield Road to the Mount Laurel Township line |
| Haines Drive | 25 | From Kings Highway to South Church Street |

Section 5: Regulatory signs shall be erected and maintained to effectuate the above designated "SPEED LIMIT" locations.

Section 6: In all other respects, Chapter 168 shall remain in full force and effect.

Section 7: Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies.

Section 8: Severability. In the event that any section paragraph, clause, phrase, term, provision or part of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid or unenforceable for any reason, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, phrase, term, provision or part thereof directly involved in the controversy if such judgment shall be rendered.

Section 9: Effective Date. This ordinance shall take effect upon proper publication in accordance with law.

Section 10: Short Title. This Ordinance shall be known as Ordinance 8-2011.
