

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 34-2011

**AMENDING CHAPTER 168-52 OF THE CODE OF THE TOWNSHIP OF MOORESTOWN
ENTITLED "VEHICLES AND TRAFFIC,
SCHEDULE II: SPEED LIMITS"
(SALEM ROAD AND SALEM CROSSING ROAD)**

BE IT ORDAINED by the Township Council, of the Township of Moorestown, in the County of Burlington, State of New Jersey, that:

Section 1: Chapter 168-52, Schedule II: "Speed Limits" of the Code of the Township of Moorestown, is hereby amended as follows:

The following language under Schedule II: "Speed Limits" shall be inserted:

<u>NAME OF STREET</u>	<u>SPEED LIMIT</u>	<u>ZONE</u>	<u>LOCATION</u>
Salem Road	25	(a)	From Westfield Road to Bramley Road
Salem Road	35	(b)	From Hartford Road to Salem Crossing Road
Salem Crossing Road	35		From Borton Landing Road to Salem Road (exception: the speed limit shall be 25mph in the school zone and the provisions of N.J.S.A 39:4-98.a. shall prevail)

Section 2: Regulatory signs shall be erected and maintained to effectuate the above designated speed limits.

Section 3: In all other respects, Chapter 168-52 shall remain in full force and effect.

Section 4: Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies.

Section 5: Severability. In the event that any section, paragraph, clause, phrase, term, provision, or part of this ordinance shall be adjudged by a court of competent jurisdiction, to be invalid or unenforceable for any reason, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, phrase, term, provision, or part thereof directly involved in the controversy, if such judgment is rendered.

Section 6: Effective Date. This ordinance shall take effect, upon proper publication and in accordance with law.

Section 7: Short Title. This ordinance shall be known as Ordinance 34-2011.
