ORDINANCE 8-2009

**AN ORDINANCE OF THE TOWNSHIP OF MOORESTOWN,
COUNTY OF BURLINGTON, STATE OF NEW JERSEY,
REPEALING AN ORDINANCE OF THE TOWNSHIP OF MOORESTOWN ADOPTED BY THE
TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOORESTOWN
ON DECEMBER 11, 2006 IDENTIFIED AS ORDINANCE NO. 32-2006**

WHEREAS, the Township Council recognizes that as a result of previous judicial intervention, the Superior Court of the State of New Jersey has determined that Chapter 96 of the Code of the Township of Moorestown is unenforceable as previously adopted; and

WHEREAS, the Township Council believes that it is in the best interest of the Township to repeal Chapter 96 in its entirety so that there is certainty as to whether or not the provisions of Chapter 96 of the Township Code should be enforced.

NOW, THEREFORE, BE IT ENACTED, by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey as follows:

1. Chapter 96 of the Township Code entitled "Historic Preservation Commission" adopted on December 11, 2006 by and through Township Ordinance No. 32-2006 is hereby repealed in its entirety.
2. The Township Clerk is hereby authorized to make note of such repeal in the official code book maintained by the Clerk's office.
3. Unless revised or modified herein all other sections of the Township Code shall remain in full force and effect.
4. If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional, invalid, or unenforceable by a court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.
5. All ordinances or parts of ordinances which are inconsistent with any provisions of this ordinance are hereby repealed as to the extent of such inconsistencies.
6. This ordinance shall become effective immediately upon final adoption.
7. This ordinance may be cited as Ordinance No. 8-2009.
