

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 20-2009

AN ORDINANCE AMENDING ORDINANCE 29-2008 ENTITLED “AN ORDINANCE AMENDING ORDINANCE NO. 734 “THE MOORESTOWN TOWNSHIP SALARIES AND COMPENSATION ORDINANCE OF 1973,” AS AMENDED AND SUPPLEMENTED, BY PROVIDING FOR SALARY ADJUSTMENTS FOR CLERICAL AND CONFIDENTIAL EMPLOYEES”

WHEREAS, Section 1A of Ordinance 29-2008 needs to be amended to add clarification regarding the clerical wage tables as they relate to hourly rates.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Moorestown in the County of Burlington, State of New Jersey that:

SECTION 1: Section 1.A. of Ordinance 29-2008 shall be amended as follows:

Section 1: The “Moorestown Salaries and Compensation Ordinance of 1973,” (Ordinance No. 734) shall be amended by inserting the following language:

- A. *Section 3.3 (a) and 3.3 (b) (clerical and confidential positions) are amended by deleting the respective wage tables and replacing them with Schedules ~~A and B~~ A, B, C, D and E CLERICAL AND CONFIDENTIAL. The attached annual salary tables represent the base pay for listed positions by step based upon an annual work schedule of 1,820 hours. All full and part-time clerical employees will be paid at a straight-time hourly rate in accordance with the salary schedules for actual hours worked up to 1,820 hours.*

SECTION 2: In all other respects, Ordinance No. 29-2008 shall remain in full force and effect.

SECTION 3: All other ordinances and parts of ordinances and resolutions, insofar as they are inconsistent with any of the terms and provisions of this ordinance, are hereby repealed to the extent of such inconsistency only.

SECTION 4: If any section, paragraph, sentence, clause, phrase, term, provision, or part of this ordinance shall be adjudged by any court of competent jurisdiction to be invalid or inoperative, such judgment shall not affect, impair or invalidate the remainder thereof phrase, term, provision, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5: This ordinance may be cited as Ordinance No. 20-2009.
