

TOWNSHIP OF MOORESTOWN

ORDINANCE NO 31-2006

AN ORDINANCE AMENDING CHAPTER 168-66 OF THE CODE OF THE TOWNSHIP OF MOORESTOWN ENTITLED "VEHICLES AND TRAFFIC - PARKING PROHIBITED CERTAIN HOURS"

BE IT ORDAINED by the Township Council, of the Township of Moorestown, in the County of Burlington, State of New Jersey that:

Section 1: Chapter 168-66. Schedule XVI: "Parking Prohibited Certain Hours" of the Code of the Township of Moorestown is hereby amended as follows:

- a. The following language, under Schedule XVI: "Parking Prohibited Certain Hours" shall be added:

| Spruce Avenue | North and South | 8:00 a.m. to 9:00 a.m. 3:00 p.m. to 4:00 p.m. School Days | From Dead End to a point 214 feet East |

Section 2. Regulatory signs shall be erected and maintained to effectuate the above-designated "Parking Prohibited 8:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m. School Days" locations.

Section 3: In all other respects, Chapter 168 shall remain in full force and effect.

Section 4: Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies

Section 5: Severability. In the event that any section paragraph, clause phrase, term, provision or part of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid or unenforceable for any reason, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, term, provision or part thereof directly involved in the controversy in such judgment shall be rendered.

Section 6: Effective Date. This ordinance shall take effect upon proper publication in accordance with law.

Section 7: Short Title. This Ordinance shall be known as Ordinance 31-2006.
