

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 30-2007

**AN ORDINANCE AMENDING CHAPTER 168-58 OF THE CODE OF
THE TOWNSHIP OF MOORESTOWN ENTITLED
VEHICLES AND TRAFFIC "STOP INTERSECTIONS"**

WHEREAS, the Township Engineer has certified that that the intersection of Wilson Avenue and North Garfield Avenue meets the requisite criteria to be designated as a stop controlled intersection.

THEREFORE, BE IT ORDAINED by the Township Council, of the Township of Moorestown, in the County of Burlington, State of New Jersey that:

Section 1: Chapter 168-58. Schedule VIII: "Stop Intersections" of the Code of the Township of Moorestown, is hereby amended as follows:

A. The following paragraph, under, Schedule VIII: "Stop Intersections" shall be added:

<u>STOP SIGN ON</u>	<u>AT INTERSECTION OF</u>
North Garfield Avenue	West Wilson Avenue and North Garfield Avenue

Section 2. Regulatory signs shall be erected and maintained to effectuate the above-designated "STOP" location, as authorized by the New Jersey Department of Transportation.

Section 3: In all other respects, Chapter 168 shall remain in full force and effect.

Section 4: Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies

Section 5: Severability. In the event that any section paragraph, clause phrase, term, provision or part of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid or unenforceable for any reason, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, term, provision or part thereof directly involved in the controversy in such judgment shall be rendered.

Section 6: Effective Date. This ordinance shall take effect upon proper publication and in accordance with law.

Section 7: Short Title. This Ordinance shall be known as Ordinance 30-2007.
