

**TOWNSHIP OF MOORESTOWN**

**ORDINANCE NO. 35-2007**

**AN ORDINANCE AMENDING ORDINANCE NO. 734 “THE MOORESTOWN TOWNSHIP SALARIES AND COMPENSATION ORDINANCE OF 1973,” AS AMENDED AND SUPPLEMENTED, BY ESTABLISHING SALARIES AND COMPENSATION, BY PROVIDING FOR THE POSITION OF “SPECIAL ASSISTANT TO THE TOWNSHIP MANAGER” AND ADJUSTING THE SALARY FOR THE POSITION OF MANAGER**

BE IT ORDAINED by the Township Council of The Township of Moorestown in the County of Burlington, State of New Jersey, that:

SECTION 1: The “Moorestown Salaries and Compensation Ordinance of 1973,” (Ordinance No. 734) as amended and supplemented, is hereby amended as follows:

A. Section 1(a) is hereby amended by adding the following salary and title:

<u>POSITION</u>	<u>COMPENSATION</u>
Special Assistant to Township Manager	\$125,000

B. Section 1(a) is hereby amended to provide that the salary for the position of Township Manager is \$125,000

SECTION 2: Section 1 A of this ordinance shall be effective from January 1, 2008 to January 30, 2008.

SECTION 3: Section 1 B of this ordinance shall be effective February 1, 2008

SECTION 4: In all other respects, said Ordinance No. 734, as amended and supplemented shall remain in full force and effect.

SECTION 5: All other ordinances and parts of ordinances and resolutions, insofar as they are inconsistent with any of the terms and provisions of this ordinance, are hereby repealed to the extent of such inconsistency only.

SECTION 6: If any section, paragraph, sentence, clause, phrase, term, provision or part of this ordinance shall be adjudged by any court of competent jurisdiction to be invalid or inoperative, such judgment shall not affect, impair or invalidate the remainder thereof phrase, term, provision or part thereof directly involved in the controversy in which such judgment shall have been rendered.

SECTION 7: This ordinance may be cited as Ordinance 35-2007
