

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 16-2008

AN ORDINANCE AMENDING CHAPTER 79 OF THE CODE OF THE TOWNSHIP OF MOORESTOWN ENTITLED "FIRE PREVENTION AND PROTECTION"

BE IT ORDAINED by the Township Council, of the Township of Moorestown, in the County of Burlington, State of New Jersey, as follows:

Section 1: The Code of the Township of Moorestown is hereby amended by deleting Paragraph 79.11 entitled Uniform Fire Code Permit Fees in its entirety and replacing it as follows:

§ 79.11. Uniform code permit fees. [Amended 3-12-2001 by Ord. No. 1949-01]

The permit fees shall be those established in Section 2.9(c) of the New Jersey Uniform Fire Code, N.J.A.C. 5:70, as follows:

Type	Fee
Type 1	\$35
Type 2	\$138
Type 3	\$276
Type 4	\$414

The following language shall be inserted in its place.

§ 79-11. Uniform fire code permit fees. [Amended 3-12-2001 by Ord. No. 1949-01]

The permit fees shall be those established by the New Jersey Uniform Fire Safety Act, N.J.S.A. 52:27D-192. et seq.

Section 2: Repealer. All other ordinances and parts of ordinances and resolutions, insofar as they are inconsistent with any of the terms and provisions of this Ordinance, are hereby repealed to the extent of such inconsistency only.

Section 3: Severability. If any section, paragraph, sentence, clause, phrase, term, provision, or part of this Ordinance shall be adjudged by any court of competent jurisdiction to be invalid or inoperative, such judgment shall not effect, impair or invalidate the remainder hereof, but shall be confined in its operation to the section, paragraph, sentence, clause, phrase, term provision, or part hereof directly involved in the controversy in which such judgment shall have been rendered.

Section 4: Effective Date. This Ordinance shall take effect twenty (20) days after the date of publication of final passage.

Section 5: Short Title. This Ordinance shall be cited as Ordinance 16-2008.
