

TOWNSHIP OF MOORESTOWN

ORDINANCE NO. 34-2008

**AN ORDINANCE AMENDING CHAPTER 168-64 ENTITLED
“PARKING PROHIBITED AT ALL TIMES” AND
168-65 ENTITLED “NO STOPPING OR STANDING”
OF THE CODE OF THE TOWNSHIP OF MOORESTOWN**

BE IT ORDAINED by the Township Council of the Township of Moorestown, in the County of Burlington, State of New Jersey, that:

Section 1: Chapter 168-64. Schedule XIV: “Parking Prohibited at All Times” of the Code of the Township of Moorestown, is hereby amended as follows:

- a. The following language under Schedule XIV: “Parking Prohibited at All Times” shall be deleted:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Lenola Road	East	From Collins Avenue to Center Street
Church Street	East	From New Jersey State Highway No. 38 to New Albany Road
North Church Street	Both	From New Albany Road to Cinnaminson Township boundary line

Section 2. Chapter 168-65. Schedule XV “No Stopping or Standing,” of the Code of the Township of Moorestown, is hereby amended as follows:

- a. The following language under Schedule XV: “No Stopping or Standing” shall be deleted.

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
North Church Street	Both	From New Albany Road to a point 350 feet north
North Lenola Road	Both	From New Albany Road to a point 150 feet north

Section 3. Chapter 168-65. Schedule XV: “No Stopping or Standing,” of the Code of the Township of Moorestown, is hereby amended as follows:

- a. The following language under Schedule XV “No Stopping or Standing” shall be inserted:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Lenola Road	East	Entire length
North Lenola Road	West	From New Albany Road to a point 150 feet north
Church Street	East	Entire length
North Church Street	West	From New Albany Road to Cinnaminson Township boundary line

Section 4: Regulatory signs shall erected and maintained to effectuate the above provisions.

Section 5: In all other respects, Chapter 168 shall remain in full force and effect.

Section 6: Repealer. Any and all other ordinances inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistencies.

Section 7: Severability. In the event that any section, paragraph, clause, phrase, term, provision, or part of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid or unenforceable for any reason, such judgment shall not effect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the section, paragraph, clause, term, provision, or part thereof directly involved in the controversy, if such judgment is rendered.

Section 8: Effective Date. This ordinance shall take effect upon proper publication in accordance with the law.

Section 9: Short Title. This Ordinance shall be known as Ordinance 34-2008.
