RESOLUTION NO. 52-2013

**AWARDING A CONTRACT TO CARDINO ATC IN THE AMOUNT OF \$61,000 FOR
THIRD PARTY TESTING AND INSPECTION SERVICES IN CONNECTION WITH
THE TOWN HALL/LIBRARY PROJECT**

WHEREAS, the Township of Moorestown (“Township”) sought Requests for Proposals (RFP), in accordance with the “fair and open” provisions of the New Jersey Pay-to-Play Laws, for construction material testing and inspection services in connection with the Town Hall/Library project; and

WHEREAS, five (5) proposals were received and publicly opened on December 10, 2012; and

WHEREAS, said submissions have been reviewed by Rob Notley, Construction Consultant, Grey Hawk Construction; and

WHEREAS, the Construction Consultant has found that Cardino ATC satisfactorily meets all the criteria set forth in the Request for Proposals and recommends that Cardino ATC be awarded a contract in the amount of \$61,000; and

WHEREAS, although the RFP was prepared and noticed in accordance with the fair and open New Jersey Pay-to-Play Laws, award was noticed in the RFP to be made under the non-fair and open provisions of the New Jersey Pay-Play-Law; and

WHEREAS, a Determination of Value Form, certifying that the costs associated with said services will exceed \$17,500, has been filed with the Township Clerk; and

WHEREAS, the Township Clerk is in receipt of a Certificate of Availability of Funds from the Chief Finance Officer; and

WHEREAS, an executed Business Entity Disclosure Certification, which certifies that the contractor has not made any reportable contributions to a political or candidate committee in the Township of Moorestown in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of the contract, has been received by the Township Clerk; and

WHEREAS, an executed Political Contribution Disclosure Form was filed with the Municipal Clerk at least ten (10) days prior to award of the contract; and

WHEREAS, the Township of Moorestown has met the provisions of the NJ Local Unit Pay-to-Play Law to award a contract under the Non-Fair and Open Contracts provisions of the Law.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. The firm of Cardino ATC, 3 Terri Lane, Suite 4, Burlington, New Jersey 08016, is hereby awarded a contract in the amount of \$61,000 pursuant to the provisions of N.J.S.A. 19:44a-20.5 (non-fair and open) and Chapter 10 of the Code of the Township of Moorestown.
2. The Mayor and the Township Clerk are hereby authorized to sign an agreement between the Township and Cardino ATC for construction material testing and inspection services, which contract shall be filed with the Township Clerk and made available for public inspection.
3. The Business Entity Disclosure Certification, Political Contribution Disclosure and Determination of Value Form shall be placed on file with this resolution.
4. The Township Clerk is hereby directed to publish a "Notice of Award" of said contract in the official newspaper in accordance with the Local Public Contracts Law.
