**APPROVING PERSON-TO-PERSON/PLACE-TO-PLACE TRANSFER OF
PLENARY RETAIL CONSUMPTION LICENSE NO. 0322-33-001-001
(MOORESTOWN BEVERAGE I, LLC TO VETRI JERSEY, LLC)**

WHEREAS, an application has been filed for a Person-to-Person/Place-to-Place Transfer of Plenary Retail Consumption License Number 0322-33-001-001 issued to Moorestown Beverage I, LLC for an inactive (pocket) license with a mailing address of 200 South Broad Street, Philadelphia, Pennsylvania 19102-3803; and

BE IT FURTHER RESOLVED that the Township Council of the Township of Moorestown does hereby approve, effective August 19, 2013 the Place-to-Place Transfer of the aforesaid Plenary Retail Consumption licensed premises, from its former business address at 200 South Broad Street, Philadelphia, Pennsylvania to its new location at Moorestown Mall, 400 Route 38, Unit 1367, Moorestown, New Jersey 08057 and does hereby direct the Township Clerk to endorse the license certificate as follows:

“This license, subject to all of its terms and conditions, is hereby transferred, effective July 22, 2013, from Moorestown Beverage I, LLC, 200 South Broad Street, Philadelphia, PA 19103 to premises located at Moorestown Mall, 400 Route 38, Unit 1000, Moorestown, New Jersey 08057.”
