

**TOWNSHIP OF MOORESTOWN  
RESOLUTION NO. 181-2013  
AWARDING A PROFESSIONAL SERVICES CONTRACT TO  
BRINKERHOFF ENVIRONMENTAL SERVICES, INC.**

WHEREAS, the Township of Moorestown awarded a contract to Brinkerhoff Environmental Services, Inc., Environmental Consultant, (“Brinkerhoff”) via Resolution 144-2010, on September 27, 2010 to provide oversight in connection with the former gasoline underground storage tank (UST) and current heating oil UST remediation at the Town Hall site; and

WHEREAS, since award of said contract, unanticipated environmental issues have been and continue to be discovered as development of the site continues; and

WHEREAS, the Township Council wishes to formally award a contract to Brinkerhoff for past and ongoing environmental consulting services, and associated work, as they relate to continued development of the site.

WHEREAS, funds are available for this purpose; and

WHEREAS, a Determination of Value Form, certifying that the costs associated with said services will exceed \$17,500, has been filed with the Township Clerk; and

WHEREAS, an executed Business Entity Disclosure Certification, which certifies that the contractor has not made any reportable contributions to a political or candidate committee in the Township of Moorestown in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of the contract, has been received by the Township Clerk; and

WHEREAS, an executed Political Contribution Disclosure Form was filed with the Municipal Clerk at least ten (10) days prior to award of the contract; and

WHEREAS, the Township of Moorestown has met the provisions of the NJ Local Unit Pay-to-Play Law to award a contract under the Non-Fair and Open Contracts provisions of the Law.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. Brinkerhoff Environmental Services, Inc., 133 Jackson Road, Suite D, Medford, New Jersey 08055 is hereby awarded a contract for professional services pursuant to the provisions of N.J.S.A. 19:44a-20.5 and Chapter 10 of the Code of the Township of Moorestown.
2. Brinkerhoff shall submit a proposal for each phase of work deemed necessary to continue development at the site. The Township Manager is hereby authorized to execute said proposal(s).
3. A contractual agreement is hereby approved and execution of the contract is authorized.
4. A copy of the aforementioned contractual agreement shall be filed in the Office of the Township Clerk and made available for public inspection.
5. The Business Entity Disclosure Certification, Political Contribution Certification and Determination of Value Form shall be placed on file with this resolution.
6. The Township Clerk is hereby authorized to publish a “Notice of Award” of said contract in the official newspaper in accordance with the Local Public Contracts Law, within ten (10) days of its passage.
