RESOLUTION NO. 12-2014

**APPOINTING ANTHONY T. DROLLAS, JR. OF CAPEHART SCATCHARD AND
AUTHORIZING AWARD OF A CONTRACT FOR
TOWNSHIP/LABOR/TAX/UTILITY ATTORNEY FOR 2014**

WHEREAS, the Township of Moorestown requires the professional services of an Attorney for the year 2014; and

WHEREAS, a Determination of Value Form, certifying that the costs associated with said services will exceed \$17,500, has been filed with the Township Clerk; and

WHEREAS, an executed Business Entity Disclosure Certification, which certifies that the contractor has not made any reportable contributions to a political or candidate committee in the Township of Moorestown in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of the contract, has been received by the Township Clerk; and

WHEREAS, an executed Political Contribution Disclosure Form was filed with the Municipal Clerk at least ten (10) days prior to award of the contract; and

WHEREAS, the Township of Moorestown has met the provisions of the NJ Local Unit Pay-to-Play Law to award a contract under the Non-Fair and Open Contracts provisions of the Law.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

1. Anthony J. Drollas, of the law firm, Capehart Scatchard, whose business address is 8000 Midlantic Drive, Suite 300S, PO Box 5016, Mount Laurel, New Jersey 08054-5016 is hereby appointed Township/Labor/Tax/Utility Attorney for the year 2014 pursuant to the provisions of N.J.S.A. 19:44A-20.5 (non-fair and open) and Chapter 10 of the Code of the Township of Moorestown. Said appointment shall expire upon the Reorganization Meeting of the Township Council in 2015.
2. A contractual agreement summarizing the services to be performed by Anthony J. Drollas, Esquire as Township/Labor/Tax/Utility Attorney and the fee of \$150.00 per hour to be charged for same is hereby approved and execution of the contract is authorized and shall be filed in the Office of the Township clerk and made available for public inspection.
3. The Business Entity Disclosure Certification, Political Contribution Certification and Determination of Value Form shall be placed on file with this resolution.
4. The Township Clerk is hereby authorized to publish a "Notice of Award" of said contract in the official newspaper in accordance with the Local Public Contracts Law, within ten (10) days of its passage.
