**AWARDING A CONTRACT TO
MILLENNIUM COMMUNICATIONS GROUP INC.

FOR VARIOUS TECHNOLOGY REQUIREMENTS FOR THE TOWN HALL, LIBRARY AND
NORTH CHURCH STREET RECREATION CENTER FACILITIES**

WHEREAS, various technology equipment is required to be furnished and installed and/or relocated in connection with the Town Hall, Library and North Church Street Recreation Center facilities; and

WHEREAS, Millennium Communications Group Inc. has provided proposals to furnish and install said equipment (hereinafter collectively referred to as the “contract”); and

WHEREAS, the Township wishes to approve and enter into the contract, pursuant to N.J.S.A. 40A:11-12 et seq., with Millennium Communications Group Inc., for the following (as fully set forth in the contract):
