RESOLUTION NO. 64-2014

**AWARDING A CONTRACT TO CASWORTH ENTERPRISES, INC. FOR
SOLID WASTE COLLECTION SERVICES**

WHEREAS, bids were received by the Municipal Clerk for Solid Waste Collection Services on November 14, 2013; and

WHEREAS, bids were received from the following six (6) contractors:

- Company Name:** South Jersey Sanitation Company
- Company Name:** Central Jersey Waste & Recycling, Inc.
- Company Name:** Waste Management of New Jersey, Inc.

WHEREAS, the bid documents have been reviewed by the Township's Consultant, Robert L. Willis, President, AVR Resource Group, Inc., who has recommended, by letter dated November 27, 2013, that the lowest responsible bidder be awarded the contract; and

WHEREAS, Casworth Enterprises, Inc. submitted the following bid prices:

Base Bid Container (municipal):	Year 1: \$2.00 Year 2: \$2.00 Year 3: \$2.00
Option No. 1 (containers):	Year 1: \$2.00 Year 2: \$2.00 Year 3: \$2.00
Option No. 2 (containers):	Year 1: \$2.00 Year 2: \$2.00 Year 3: \$2.00

WHEREAS, the Deputy Manager/Chief Finance Officer has filed the required Certification of Funds with the Township Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that

1. The contract for Solid Waste Collection Services is hereby awarded to the lowest responsible bidder, Casworth Enterprises, Inc., which includes Base Bid Curbside and Container Collection and Option Nos. 1 and 2.
2. Said contract shall be for a period of three (3) years commencing on February 3, 2014 and terminating on January 31, 2017 (with the exception of Option No. 1 which shall be for a period of two (s) months February 3-March 31, 2014).
3. The Mayor and Township Clerk are hereby authorized to sign said contract and other documents necessary to implement this resolution.
