RESOLUTION NO. 86-2014

**A RESOLUTION AMENDING AND SUPPLEMENTING
THE 2014 TEMPORARY BUDGET**

WHEREAS, the Township of Moorestown in the County of Burlington, New Jersey adopted its 2014 Temporary Budget on January 6, 2014 to cover budgetary appropriations through the first three months of the year; and

WHEREAS, the 2014 Budget has not yet been introduced; and

WHEREAS, it is necessary to amend and supplement the 2014 Temporary Budget by two-twelfths of the total of appropriations for each fund in the preceding year, exclusive of appropriations for debt service, the Capital Improvement Fund, and Public Assistance to meet its current salary and wages and operating obligations through the months of April and May 2014; and

WHEREAS, two-twelfths of the total 2013 appropriations for the Current and Utility Funds, exclusive of debt service, the Capital Improvement Fund and Public Assistance is as follows:

Current Fund: \$3,287,203
Utility Fund: \$1,198,554

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown in the County of Burlington, New Jersey that the following 2014 temporary appropriations are hereby supplemented and amended as follows:
