

**TOWNSHIP OF MOORESTOWN**

**RESOLUTION NO. 170-2014**

**A RESOLUTION REQUESTING APPROVAL OF THE INSERTION OF ITEMS OF REVENUE AND APPROPRIATION TO AMEND THE 2014 ADOPTED BUDGET (N.J.S.A. 40A:4-87)**

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of an item of appropriation for an equal amount; and

WHEREAS, the Township of Moorestown has received grant awards of \$40,041 from the Solid Waste Administration – Clean Communities Grant; \$60,000 from the Division of Criminal Justice – Safe and Secure Communities Grant; and a \$20,000 supplemental increase in award from Rutgers – SNJ Enhanced Stormwater Management Grant and wishes to amend its 2014 Budget to include these amounts as a revenue; and

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Moorestown in the County of Burlington, State of New Jersey, hereby request the Director of the Division of Local Government Services to approve the insertion of the following items of revenue in the budget of the year 2014 in the amount of \$120,041 which is now available as a revenue from the following sources:
