RESOLUTION NO. 112-2020

**AWARDING A CONTRACT TO CENTRAL JERSEY WASTE & RECYCLING, INC.
FOR SOLID WASTE COLLECTION SERVICES**

WHEREAS, bids were received by the Township Manager/Chief Financial Officer for Solid Waste Collection Services on April 8, 2020; and

WHEREAS, bids were received from the following two (2) contractors:

Company Name: Central Jersey Waste & Recycling, Inc.

Company Name: Republic Services of NJ, LLC

WHEREAS, the bid documents have been reviewed by the Township's Consultant, Amber Day, Vice President of Operations, TrashPro, who has recommended, by letter dated April 14, 2020, that the lowest responsible bidder be awarded the contract; and

WHEREAS, Central Jersey Waste & Recycling, Inc. submitted the following bid prices:

WHEREAS, the Chief Financial Officer has certified funds in the amount of \$768,023.08 (Appropriation No.0-01-26-305-000-575), \$788,363.97 (Appropriation No. 1-01-26-305-000-575) and \$810,493.54 (2-01-26-305-000-575).

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey, that:

1. The contract for Solid Waste Collection Services is hereby awarded to the lowest responsible bidder, Central Jersey Waste & Recycling, Inc. which includes Base Bid Curbside and Container Collection.
2. Said contract shall be for a period of three (3) years commencing on May 1, 2020 and terminating on April 30, 2022 with the option to extend for additional two 1-year periods.
3. The Mayor and Township Clerk are hereby authorized to sign said contract and other documents necessary to implement this resolution.

RECOMMENDATION

The Township received two bids for the solid waste collection services. We recommend Approving the resolution to the lowest qualified bidder Central Jersey Waste (Solterra) for a 3 Year Contract with the option to renew for two 1 year extensions.

PREVIOUS ACTION

Central Jersey Waste had the previous contact for years April 1, 2017-March 31, 2020. They declined the exercise of the first option year. The Township had to extend the contract for one month while we went back out to bid.

BACKGROUND

The Township of Moorestown has contracted the collection of solid waste since 2014

FISCAL IMPACT

The first year of the contract will be charged to acct# 0-01-26-305-000-575 in the amount of \$64,001.92 per month or \$768,023.08 annual cost. This is an annual increase of \$171,679.92 (\$14,306.66/month) over the previous contract.

3 year contract total \$ 2,366,880.59 (Yr. 1-\$768,023.08, Yr. 2-\$788,363.97, Yr. 3-\$810,493.54 respectively)
2- 1 year extensions total \$ 1,685,610.86 (Yr. 4-\$831,758.36, Yr. 5-\$853,852.50, respectively)
