RESOLUTION NO. 37-2022

SETTING THE ANNUAL MEETING SCHEDULE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOORESTOWN FOR 2022

WHEREAS, the "Open Public Meetings Act," Chapter 231, P.L. 1975, requires adequate notice of meetings of public bodies as defined therein; and

WHEREAS, said act also requires notice of the schedule of annual meetings of said bodies.

NOW, THEREFORE, BE IT RESOLVED, that the following shall set forth the meeting schedule for the year 2022:

1. The Reorganization Meeting of the Township Council for the year 2022 will be held at Town Hall, Council Chamber, 111 West Second Street, Moorestown, New Jersey at 7:00 p.m. on January 3, 2022.

2. Thereafter, during the year 2022, the Moorestown Township Council shall meet and hold Official Action Meetings in the Town Hall, Council Chamber, 111 West Second Street, Moorestown, New Jersey, each month beginning at 7:00 p.m. on the dates listed on the attached Notice of Annual Meetings and Township Council Schedule of Meetings, unless otherwise noticed. Unless otherwise necessary, Closed Session meetings will immediately follow Official Action meetings.

3. Due to the COVID-19 pandemic and in order to aid in protecting the health, safety and welfare of the citizens while ensuring the continued functioning of government, public attendance at meetings will be offered in the following ways. 1) in person; 2) via telephone; and 3) virtually via MSTeams. Members of the public can participate in all meetings just the same as if at an in-person meeting. The Mayor will open the floor for public participation in accordance with normal protocol. Instructions on how to participate via the telephone and MSTeams will be printed on the agenda for each meeting.

4. A Dinner Meeting to honor Board and Committee members will be held on the date and time listed on the Annual Meeting Schedule at a location yet to be determined.

5. Special Meetings of Township Council may be called by the Mayor; three or more members of Council; or the Township Manager.

6. In addition to the foregoing, a special meeting may be called by the Mayor, at any time, with such notification to Council Members, the Township Clerk, and the public, in accordance with law, as the Mayor shall deem appropriate; and such meeting shall be a proper and valid meeting provided four members of the Council are in attendance at the start of the meeting and an affirmative vote of four members of Council is taken that the meeting may be held.

7. Notice of a special meeting shall be delivered to each Councilmember and the Office of the Township Clerk at least 48 hours prior to the time of the special meeting. Notice shall also be given to the public in accordance with law.

8. Two Dollars (\$2) per month is hereby determined to be the sum to be charged for copies of Township Council meeting notices and agendas; however, notices requested by the news media shall be mailed to such news media free of charge (see N.J.S.A. 10:4-19).

9. The Notice of Annual Meetings and Township Council Schedule of Meetings for the year 2022 is annexed hereto and the Township Clerk is directed to post, mail and file said Notice and Schedule as required by law. The Township Clerk shall also prepare, post, mail, file and maintain all other notices required by the State of New Jersey Open Public Meetings Act (N.J.S.A. 10:4-6 et seq.).

10. Anyone in need of special accommodations or access due to disability may contact the Township Clerk by telephone at 856-235-0912. Assisted listening devices are available at all Township Council meetings.
