**A RESOLUTION SETTING THE ANNUAL MEETING SCHEDULE OF THE ZONING BOARD
OF ADJUSTMENT OF THE TOWNSHIP OF MOORESTOWN FOR 2026**

WHEREAS, the “Open Public Meetings Act,” Chapter 231, P.L. 1975, requires adequate notice of meetings of public bodies as defined therein; and

WHEREAS, said act also requires notice of the schedule of annual meetings of said bodies.

NOW, THEREFORE, BE IT RESOLVED, that the following shall set forth the meeting schedule for the year 2026:

1. During the year 2026, the Board of Adjustment shall meet at the Moorestown Town Hall, 111 West Second Street, Moorestown, New Jersey, or Virtually each month at 7:00 p.m. on the dates listed on the attached Notice of Annual Meetings and Schedule of Meetings, unless otherwise noticed.

2. The Board sets the date and time for its reorganization meeting of 2027 as January 19, 2027, at 7:00 p.m. in the Moorestown Town Hall, 111 West Second Street, Moorestown, New Jersey or Virtual Meeting.

3. The Chairman; Vice-Chairman; or two or more members of the Board of Adjustment may call special Meetings of the Board of Adjustment.

4. The Notice of Annual Meetings and Schedule of Meetings for the year 2026, and for January 2027, is annexed hereto and the Board Secretary is directed to post, mail and file said Notice and Schedule as required by law. The Board Secretary shall also prepare, post, mail, file and maintain all other notices required by the State of New Jersey Open Public Meetings Act, Chapter 231, and P.L. 1975.

5. Anyone in need of special accommodations or access due to disability may contact the Board Secretary by telephone at 856-235-0912. Assisted listening devices are available at all Board of Adjustment meetings.

6. The Burlington County Times is the official Township of Moorestown newspaper, and the Courier Post is the alternate official Township of Moorestown newspaper. In accordance with P.L. 2025, c.72, beginning on March 1, 2026, all public notices of the Zoning Board of Adjustment will be available under “Legal Notices” on the homepage of Moorestown Township’s website at www.moorestown.nj.us as opposed to an official newspaper.

A motion duly made by HANUSCIN and duly seconded by D'ANTONIO that the above resolution be adopted. The above resolution was adopted by a 6 to 0 vote of the Township of Moorestown Zoning Board of Adjustment at a meeting held on January 20, 2026.
