**A RESOLUTION SETTING THE ANNUAL MEETING SCHEDULE OF THE
PLANNING BOARD OF THE TOWNSHIP OF MOORESTOWN FOR 2026**

BE IT RESOLVED by the Planning Board of The Township of Moorestown, in the County of Burlington, in the State of New Jersey, as follows:

1. Regular meetings of the Moorestown Township Planning Board will be held during 2026 at 7:00 p.m. in the Council Chambers, Town Hall, 111 West Second St., Moorestown, New Jersey 08057, according to the attached Annual Schedule of Meetings, unless otherwise noted.
2. The Planning Board also establishes the date, time and place for its **first meeting of 2027, as January 14, 2027** at 7:00 p.m. in the Council Chambers, Town Hall, 111 West Second St., Moorestown, New Jersey 08057. This will be the reorganization meeting and will establish the "Annual Notice," and the selection of the slate of officers.
3. The approval of minutes and memorialization of resolutions may take place at any meeting.
4. The Planning Board Chairman may at any time appoint members to committees and designate the chairman of each committee.
5. The Planning Board Chairman may at his/her discretion assign or delegate other functions and responsibilities to individual members of subcommittees of the Planning Board. Any such assignment or delegation shall be reported by the Chairman to the Planning Board at its next regular meeting following the assignment or delegation.
6. Special meetings of the Planning Board may be called by:
 - a. The Chairman;
 - b. The Vice-Chairman;
 - c. Three (3) or more members of the Planning Board.
7. Notice or call of a special meeting shall be delivered to the Planning Board members, the Office of the Township Clerk, the official newspapers of the Planning Board, and posted in the lobby of Town Hall, at least 48 hours prior to the time of the special meeting.
8. The following are designated official newspapers from January 1, 2026 through February 1, 2026: Burlington County Times as the Official Newspaper; and Courier Post as the Alternate Official Newspaper. In accordance with P.L. 2025, c.72, beginning on March 1,

2026, all public notices of the Planning Board will be available under “Legal Notices” on the homepage of Moorestown Township’s website at www.moorestown.nj.us as opposed to an official newspaper.

A motion duly made by ABERANT and duly seconded by THOMAS that the above resolution be adopted. The above resolution was (adopted or denied) by a 8 to 0 vote of the Township of Moorestown Planning Board at a meeting held on January 15, 2026.
